Sub: Commencement of disposal of Moong procured under PSS during Kharif-2024 in the State of Haryana – reg.

It has been decided to commence sale of Moong procured under PSS during Kharif-2024 in the State of Haryana. IT Division, HO has been advised to post following notice on Nafed Website immediately:

"Nafed will commence the sale of Moong procured under PSS during Kharif-2024 in the State of Haryana from 27.01.2025. Details of quantity and location can be viewed at Tender on the site".

2. Chandigarh Branch is requested to post the details announcing the commencement of sale of Moong Kharif-2024 from **27.01.2025 in the State of Haryana** on Nafed's website at TENDER Section. The prospective buyers may view the details, when visiting the website or after looking at the Pointer Advertisement which is to be released immediately by the branch.
3. Before commencement of disposal, following actions are required to be taken by the branch immediately:-
 - i. Release pointer advertisement in the local daily informing the commencement of sale of PSS Moong Kharif-2024 in the State of Haryana, detailing the quantity, location, commodity and commencement of disposal. The advertisement may read as under:-
"Nafed (Name of the branch) is commencing the sale of Moong procured under PSS during Kharif-2024 lying in various warehouses in the State of _____ (Name of State) from _____ (Date of Commencement) through e-auction platforms empanelled by NAFED. Interested buyers may visit NAFED's website www.nafed-india.com/tenders for the stock locations and sale procedure."
 - ii. Dal processing Millers Association should be intimated of the commencement of sale.
 - iii. State Civil Supplies Corporation/State Agencies dealing with Pulses should be informed.
 - iv. Notice for commencement of sale to be put up on branch's notice board.
 - v. Email to empanelled buyers to be sent informing them about the sale.
 - vi. Notice for sale should be displayed at warehouses where our stock is available for information of the local buyers.
 - vii. A notice on e-auction platforms website, including intimation to empanelled buyers and advertisement in local newspaper should also be arranged for information of buyers.
4. In addition to above, efforts for wide publicity of the sale be made by the branch. Regional Head (NZ) is also requested to coordinate with the branch for smooth disposal of Moong stock after due publicity.
