### ORDER

Whereas, in response to the e-auction regarding sale of wheat through e-auction under OMSS(D) 2024-25, M/s. South India Foods had participated in e-auction of wheat held on the M Junction portal on 04.12.2024. The entity was allotted 20 Mts of wheat under Divisional Office, Coimbatore.

Whereas, M/s South India Foods has participated in e-auction dated 04.12.2024, 11.12.2024 and 18.12.2024 and won a quantity of 20 MT, 20 MT and 25 MT wheat respectively.

While verifying the documents submitted by the party for issuance of RO, discrepancies have been noticed by DO Coimbatore. The party has submit a forged stock declaration statement showing stock declared on WSMS portal on 29.11.2024 which was actually declared on 30.11.2024(as per portal). RO was not issued by DO Coimbatore for quantity won in respect of e-auction dated 04.12.2024 and 11.12.2024.

Accordingly, Show Cause Notice vide even no. dated 30.12.2024 was issued to M/s.South India Foods to explain the reasons for submitting a forged stock declaration statement.

And Whereas, M/s.South India Foods submitted their explanation on 30.12.2024 and the same is not convincing to the undersigned.

Therefore, in exercise of point no. 14 of undertaking Appendix-IV /Appendix-IV and Clause 10(L) M/s. South India Foods is hereby debarred for participation in any e-auction for sale of wheat and rice under OMSS(D) for a period of one year from the date of issuance of this order together with forfeiture of EMD amount.

If the bidder is not satisfied/still aggrieved with the decision, an appeal lies with ED(South), FCI, Zonal Office, Chennai.

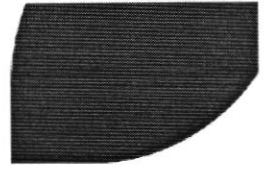
